Subject: Constitution of Primary Education and Primary Health Committee.

The Chandigarh Administration has transferred Primary Education and Primary Health to Municipal Corporation Chandigarh, therefore, the following powers and functions are proposed to be assigned to Primary Education and Primary Health Committee.

A. Powers and Functions of Primary Education Committee.

1. To sanction works like repair, maintenance and construction upto Rs.15.00 lacs.
2. To Advise regarding:
Providing facilities like scholarship, stipend, uniform, text books, lunch box, water bottles, shoes, socks, mid day meal and teaching learning material etc.
3. To advise measures for bringing pupil teacher ratio as per the norms.
4. To inspect the MCC schools
5. To formulate policies regarding modernization of schools making schools environment more attractive & friendly for Teachers & Students.

B. Powers and Functions of Primary Health Committee.

1. To sanction works like repair, maintenance and construction upto Rs.15.00 lacs.
2. To Advise regarding:
Facilities like Wheel chair, Stretchers, Filtered drinking water, Barrier free entrance, Immunization, Maternal & child care, Essential drugs, Curative services for common ailments and injuries, Disposal of wastes, Vector and reservoirs & Sitting arrangement in the Dispensaries. Organization of community awareness programmes/education.
3. To advise measures for bringing doctor patient ratio as per the norms.
4. To inspect the MCC Dispensaries.
5. To formulate policies regarding modernization of dispensaries making dispensaries environment more healthy for Patients & Doctors.

AGENDA ITEM NO. 4

Subject: Action taken report on the inquiry report submitted by Sh. Lalit Siwach, Additional Commissioner, MC, Chandigarh into the illegal laying of cables in Sectors 33 & 34, Chandigarh.

In the 167th meeting of the General House an inquiry was entrusted to Sh. Sunil Bhatia, Additional Commissioner, Municipal Corporation, Chandigarh regarding the illegal laying of cables in Sectors 33 & 34, Chandigarh by M/s PGCIL & M/s Digi Cables Networks Pvt. Ltd. Sh. Sunil Bhatia submitted his inquiry report which was placed in the 169th meeting of the General House and after considering the inquiry report the General House decided to get the inquiry conducted again by the Vigilance Officer of Municipal Corporation. Thereafter Sh. Lalit Siwach, Additional Commissioner, MC, Chandigarh-cum-Vigilance Officer conducted the inquiry and submitted his inquiry report.

In the 174th meeting of the General House the following resolution was passed:

“The Mayor said that the enquiry report has already been submitted to the Commissioner, Municipal Corporation, Chandigarh and the Commissioner would take action on the enquiry report submitted by the Vigilance Officer, Municipal Corporation, Chandigarh and would place action report in the next meeting of General House.”

On the basis of the enquiry report, Commissioner, MC has passed the following orders:

- 1) The case be put up for issuance of charge-sheet for major penalty to Sh. Vishal Gupta, Executive Engineer, Roads Division No.1, MC, Sh. Ajay Garg, SDE, Roads and Sh. Ankur Bansal, JE (Roads)
- 2) The Chief Engineer to conduct an independent enquiry to assess the financial loss to MC (if any).
- 3) The case be put up for issuance of show cause notices to the companies M/s PGCIL & M/s Digi Cables Networks Pvt. Ltd., as to why they should not be blacklisted.

The above action taken report is submitted for the information of the General House.
