At the outset, the Secretary welcomed the Mayor, Sh. Pawan Kumar Bansal, Minister of Parliamentary Affairs, Councillors, Officers and the Media persons present in the meeting.

Sh. Pardeep Chhabra congratulated the Mayor and said that during her Mayor-ship the Corporation executed number of development projects. Some long pending projects were cleared by the Chandigarh Administration. He said that under the guidance of Sh. P.K. Bansal, Minister of Parliamentary Affairs and the Administrator U.T., Chandigarh, the Corporation has been strengthened as some more functions have been transferred to it. He said that during her tenure many projects worth crore of rupees and budget of huge amount was approved by the House. He again thanked Sh. P.K. Bansal for facilitating to increase grant-in-aid under JNNURM, plan and non plan head.

Sh. Ram Sumer Morya said that his ward has been neglected and no action has been taken to sort out the problems being faced by the residents of Colony No.5, Sector-49, 50 etc. He further said that a green belt was proposed to be developed in his ward, but no work has been taken up in this regard so far despite that the Mayor herself visited the area along with Commissioner. The residents of his ward are facing acute shortage of drinking water.

The Mayor said that due to delay in connections water supply, the Horticulture Wing could not fully develop that Green Belt, but assured that it will be earnest endeavour to get the green belts developed in Sector-51 & 56. She assured that the problem of shortage of water will be sorted out at the earliest.

Sh. P.K. Mukherjee said that the House had passed an agenda for construction of two UGRs in Dadumajra 18 months ago but the said project was not mentioned in the list of action taken report.

The Commissioner said that information on this project will be supplied to him.

Sh. Ram Lal said that no development is being taken up in village Hallomajra on the plea that 70% houses are out of "Lal Dora". He said that the residents of village Hallomajra cast their votes in the election of M.P. and Councillor as well and we have to face them for non-development of their area. He asked, what action the Corporation is taking for development of all the nine villages transferred to it? He requested that at least water, electricity and roads should be provided to the residents of villages.

Sh. Pawan Kumar Bansal said that there are some legal hurdles in development of villages as there are some provisions in Capital of Punjab Development and Regulation Act, Periphery Act, which cannot be explained to all. However, the administration has agreed that basic amenities should be provided to the residents of Chandigarh. He quoted an example of Manimajra, where some area was regularized. The matter of Deep Complex at Hallomajra is also under consideration of Chandigarh Administration and he hoped that the said area will also be exempted. He further said that suggestions are coming for inclusion of all the remaining villages in the Municipal Corporation, Chandigarh so that the issue of "Lal Dora" would not be there, however, Periphery Control Act will be applicable. He asked the House to take a decision in this matter and approach the Administrator U.T., Chandigarh to include the remaining villages in the Corporation, so that appropriate funds could be allocated for development of villages and their representatives will also be in House.

Smt. Harjinder Kaur said that in the year 2007, the matter was taken up with the Administration and it agreed to transfer five villages initially to the Corporation and a committee was

constituted and the Deputy Commissioner was also part of it, which proposed to develop colonies and villages as model in phase manner and Bapu Dham Colony was developed under this system. A master plan was also proposed for development of village Palsora. She lamented that with change of Mayor in Municipal Corporation every year its priorities also change. She was of the view that the House should take decision regarding transfer of all villages to the Corporation as suggested by Sh. P.K. Bansal. She said that there is ward development fund at the disposal of Councillors so that immediate developmental work could be executed at the discretion of the area Councillor. She had given in writing to provide playing equipments in her ward, but even after lapse of four months the said equipments have not been installed, whereas similar playing equipments have already been installed in other wards.

The Mayor said that she has already discussed the issue with the XENs and has directed them to complete all the works under Ward Development Fund.

Sh. Manjit Singh said, it has been decided that internal roads and drinking water is to be provided to the colonies and as a result LBS Colony, Adarsh Colony, Nehru Colony have been provided these facilities. Regarding Palsora Village a plan has been approved according to which development will be done and a five members Committee has already been constituted for this purpose.

Brig. K.S. Chandpuri (Retd.) said that a project of tertiary water amounting to Rs.28 crore was approved by the House 2½ years ago under which pipes have already been laid down in some areas. During the discussion on agenda for 2<sup>nd</sup> Phase of this project, he had objected on the ground that tertiary water is not being supplied to the area where pipes have been laid. He asked whether tertiary water is being supplied and whether payment was released to the contractor before completion of this project? Pipes worth Rs.28 crore have been laid underground which are useless and again the similar project has been passed for 2<sup>nd</sup> phase. He asked the reason for this wastage of fund.

The Commissioner replied that the total cost of this project is Rs.36 crore and 2 installments of grant-in-aid for this project have been received from Govt. of India. There are four components of this project and construction of tertiary treatment plant is one of them. The said plant has been constructed and is under trial and the DOD level is up to expected level. Third party testing has been proposed for this plant and water is being supplied to the area covered under 1<sup>st</sup> phase. Second component is main distribution system under which 16½ km pipes are to be laid down out of which 12 km length of pipes have already been laid. Under 3<sup>rd</sup> phase HDP pipe lines have been laid in 90% area and now only connection is to be given to the pipes. Under this project four UGRs are to be constructed out of which two UGRs will be completed shortly from which TT water will be supplied to the city and the remaining two UGRs will be completed within next six months. The project was delayed for some time as a piece of land belongs to GREF, but the matter has been sorted out. The plant will be completed up to 31<sup>st</sup> March, 2011.

Dr. Pam Rajput congratulated the Mayor for successful tenure and said that Mahila Bhawan was her dream project but it seems that it will remain a dream. This project was approved by the House during the tenure of Smt. Harjinder Kaur and land was also allotted. Sh. Pardeep Chhabra constituted Women Empowerment Committee and the Chandigarh Administration declared it a Standing Committee. She regretted that no proposal of this Committee was approved, neither it got support. She also tendered her resignation from the Chairpersonship of the committee to the Commissioner without disclosing it to anyone, but no action was taken on it. Four years have passed but Mahila Bhawan is yet to be started. She further said that in the first meeting of the Women Empowerment Committee, it was decided that 50% members of Ward Committees should be women. It was also discussed in the House but no action was taken on it. She further said that the Administration has transferred some primary schools located in periphery areas whereas elite schools are with Chandigarh Administration. Similarly some dispensaries have been transferred to Corporation, whereas entire Education and Primary Health

Department should have been transferred to Corporation. She further said that in the Municipal Act nowhere it has been mentioned that nominated councillors are only in advisory capacity. Only difference is that nominated councillors have not been provided Ward Development Fund. She requested that whatever nominated councillors say should be taken seriously and due weightage should be given to their views.

The Mayor thanked Dr. Pam Rajput for her contribution and efforts for Mahila Bhawan and Women Empowerment Committee and said that Mahila Bhawan is the dream project of all women of Chandigarh. She said that during her tenure she got the building plan of Mahila Bhawan approved from the Architect Department and now construction material is available at the site and the construction is going to be started soon.

Sh. Arshad Khan said that in the first meeting of this House he had suggested to provide GPS & GIS System in Corporation. A Committee was also constituted to dwell upon this issue and 3 meetings were also convened and presentations were given in the presence of Chief Engineer and S.Es but all his efforts have gone waste. Under GIS System underground imaginary was to be prepared, which would have been beneficial in repairing work and a huge amount could have been saved. He asked, if Siliguri, Vizag, Pune can implement this system then why can't Chandigarh? He further said that even cycle track project has not been matured. Similarly the issue of fish market was raised by him and suggested that these shops were to be given on rent to the persons engaged in this business for last 15-20 years, but these shops were put on auction. He had raised issue of e-waste, but so far it has not been decided as to who will deal with this matter, either Chandigarh Administration or the Corporation.

The Commissioner said that the Committee constituted for GIS & GPS System should give its report to the House and House is to discuss on this issue and decide accordingly.

Sh. Chander Mukhi Sharma said that a detailed wing-wise structure of the project was prepared and concerned officer was apprised about the detail, from where the tender documents would be available, but the officers are not ready to do anything neither any message for the meeting of the said committee was received.

Dr. Amrit Bolaria said that Corporation is spending about Rs.6.00 crore annually, which is totally disaster and the system is being run on ad-hoc basis, as there is no proper internal and external audit system. E-governance is not in place in this office, which is a tool for proper running of an organization. She further said that the Mayor had assured that amendment in the Bye-laws for running of community centres would be placed before House in this meeting but it is not there.

The Mayor assured that it will be discussed in the meeting of House in the month of January.

Sh. Arshad Khan said that Malba Bye-Laws were approved in the House but have not been notified so far.

### **AGENDA ITEM NO. 1**

#### **QUESTION/ANSWER**

##### **Question No.1 By Smt. Kamlesh, Councillor**

The Secretary placed agenda item No.1 before House for discussion.

Smt. Kamlesh said that the detail of the salary being paid to the employees engaged on contract has not been given in the reply, so that comparison in their salary could be made out. She further said that the reply received from Public Health does not cover all the categories of employees i.e. daily wagers, outsourced & on contract. She said that the reply to the first part of her question regarding

pipelines is not given in detail, therefore, reply be given in detail. After submission of her question, the pressure of water supply was improved in Dadu Majra only for two days and signature of residents were obtained, but the situation of water supply is still poor.

Sh. Jatinder Bhatia said that the water supply in southern sector is very poor and it is going to be worse in the coming summer season. He further said that an amount of Rs. 136.00 crore has been sanctioned under JNNURM for laying pipes for water supply but even 5% benefit of those pipes has not been achieved. Whenever water is supplied, leakage erupts.

Sh. Chander Mukhi Sharma said that reply to the first part of question by Smt. Kamlesh has been supplied in the House and after going through it, it seems that the office is trying to hush up the matter by submitting such a cryptic reply.

*The Mayor said that the detailed reply of 1<sup>st</sup> part of the question be given in the next meeting of the House.*

**Question No.2 By Smt. Harjinder Kaur.**

Smt. Harjinder Kaur said that the reply given by the office to her question is not complete and only the number of officials posted in different wings has been given. She asked why the enforcement inspectors have not been posted in their original cadre?

The Commissioner said that the enforcement staff is being transferred after every 2-3 months to check any nexus. However, regular sub-inspectors posted in office are few whereas requirement is much more. Some Sub-Inspectors were involved in CBI which have been now acquitted and they are adjusted in the office and they are regularly pressurizing for posting in enforcement wing. Sub Inspectors are posted on the basis of effectiveness & reputation.

The Mayor said that she had also pointed out this issue in the meeting of F&CC and suggested that this issue be examined in the meeting of Enforcement Committee in which Smt. Harjinder Kaur can be invited as special invitee.

Smt. Harjinder Kaur said that nobody has approached her in this regard. She asked the parameters of credibility being adopted by the office. She asked the detail of the non-cadre officials posted in enforcement wing and duration of their posting, and since when the actual Sub Inspectors have been posted in other branches. She desired that the officials appointed for a particular job should be posted there.

**The Mayor said that detailed information be supplied and placed before the House in next meeting.**

Sh. Devinder Singh Babla said that the Enforcement Wing adopt pick and choose policy. A poor tea vendor is regularly challaned whereas big shopkeepers are spared. The High Court has ordered that no mechanic will repair vehicles in Sector-21, 27 & 28 but mechanics are doing their business in front of residential houses and despite regular complaint no mechanic is being removed from there.

### **Table Agenda Item No.3**

#### **Regularization of special meetings of Municipal Corporation, Chandigarh held on 28.8.2009 and 8.10.2009.**

The Mayor said that a table agenda has been moved by some members regarding regularization of special meetings of Municipal Corporation, Chandigarh held on 28.8.2009 & 8.10.2009 as the audit department has issued a letter to former Mayor Smt. Kamlesh to deposit the amount incurred

during the meetings as these meetings were not regular meetings. She desired that this agenda be discussed first.

Smt. Kamlesh said that in the year 2009, she had convened two meetings on 28.8.2009 & 8.10.2009 on the basis of decision taken by the House. But now she has received a letter from the office that the expenditure incurred during these meetings amounting to Rs. 87,358/- will be recovered from her as no business was transacted in these meetings. She asked whether Mayor cannot convene a meeting of House more than once.

Sh. Chander Mukhi Sharma said that the objective of this letter is not clear. Audit para is to be replied by the office first rather than sending the letter direct to the Ex-Mayor. He further said that one of the meeting was convened to discuss the report of the committee, which was constituted by the House due to non-action of the officials and show cause notice issued to the Garbage Processing Plant. He had specifically written a letter to the then Mayor, because the Commissioner had issued show cause notice to the Garbage Processing Plant, there is no need to discuss the report of the Committee as it would have given benefit to the plant in the court of law, and requested to postpone the meeting till decision of the High Court. He said that the letter is intentional and sought action against the concerned official and said that a message be given to the bureaucracy that the decision of the House is not being taken seriously. It is shameful to issue such letter to Ex-Mayor. Such recovery should be done from the concerned officers for non-action on the decision of the House.

Sh. Pawan Kumar Bansal, M.P. wondered that such letter has been issued to the Ex-Mayor. There is provision in the Act that at least one meeting can be convened in a month, however, if 1/4<sup>th</sup> members desire, another meeting can also be convened. The contents of the letter are not clear and this letter should not have been issued and need to be withdrawn as the auditor has overstepped his brief.

Sh. Pardeep Chhabra said that this letter has been written after one year of the meeting which shows that there is no proper audit system. It was decided in the House to convene a special meeting to discuss the report of the Committee as the Commissioner was not present in that meeting.

Sh. Pawan Kumar Bansal, M.P. read out the contents of Section 55(i) and said that there are two parts in the provision under which the Mayor can call special meeting of the House and if 1/4<sup>th</sup> members of the House so desire meeting has to be convened.

The Mayor said that the House should resolve that this letter be withdrawn and said that she will also take up the matter with the Secretary Local Government.

**The Commissioner said that there is no need to take up the matter with Secretary Local Government. On the basis of sentiments of the House, the office will write a letter to the audit department that this para be dropped.**

**The House adjourned for tea break at 12.55 p.m. and reassembled at 1.25 p.m.**

Sh. M.P.S. Chawla said that whenever a nominated Councillor requests the officers for any development in a particular area, the officers ask them to get it in writing from the elected area Councillor.

The Mayor said that so far as the development of the city is concerned, the nominated Councillors also have equal right to ask for development work. She asked the Commissioner to direct the officers to get the work done.

Sh. Devinder Singh Babla said that a park is being developed behind Tribune Colony. The residents of the area requested him to develop the adjoining space along with the said park. He suggested to them to approach the area Councillor. But, now it has come to know that a store is being constructed on that land. He requested that the said space be also developed as park.

## **AGENDA ITEM NO. 2**

### **RCE for P/F 25mm thick SDBC in parking along Madhya Marg, Sector 8 C, Chandigarh.**

The Secretary placed agenda item No.2 before House for consideration.

Sh. Pallav Mukherjee asked the certification on requirement of present estimate. He was of the view that office should consider to strip the already laid material and re-use it as the level of ground is increasing every time. This System is being used all over India. He further suggested that Porous Concrete Paving should be used. He also desired that second opinion on this issue be obtained.

The S.E.(B&R) explained that the machinery and technique used in proposed system is very expensive and only 25% extracted material is re-used depending upon its quality and this technique is not possible in parking area as its condition is very bad.

Dr. Amrit Bolaria supported Sh. Pallav Mukherjee and said that being an Engineer his version should be taken up seriously and as suggested by him every project should be considered environmentally and ecologically and report from 3<sup>rd</sup> party be taken and decide what is wrong and what is right.

***“The House considered and unanimously resolved that the estimate amounting to Rs.55.11 lac for providing and fixing 25mm thick SDBC in parking along Madhya Marg, Sector 8 C, Chandigarh, be and is hereby approved.”***

## **AGENDA ITEM NO. 3**

### **Estimate for rehabilitation of 10 MGD capacity existing Tertiary Treatment Plant, Diggian Mohali, Chandigarh.**

The Secretary placed agenda item No.3 before House for consideration.

Sh. Arshad Khan said that there are two types of road materials RBI-81 and ISS-9000, which should be used for carpeting of roads, as they give five times more durability to road and cost 25% less and more road can be laid in one day. These both materials are approved by NHAI and is being used in many National Highways.

The Mayor asked the officers to invite the concerned parties and see the presentation on these materials.

Sh. P.K. Mukherjee said that Municipal Corporation is paying lacs of rupees to a bitumen consultant every year. He asked the details of such consultants. He requested that this project be got checked through 3<sup>rd</sup> party.

Sh. Ram Lal and Sh. Gurcharan Dass Kala said that most of the projects approved by the House and the F&CC are lying pending due to non-availability of material then what is the need to approve more and more estimates. In the last meeting it was decided that the officers should come with solution for this problem, therefore the problem of shortage of material should be solved first.

Sh. Devinder Singh Babla said that many projects are pending due to non-availability of material and as such the funds cannot be utilized properly, which would result lapse in budget. Rates of material have increased, therefore, contractors be invited and their views should be obtained. He was of the view that the Commissioner should take up this matter with Chandigarh Administration, otherwise no project can be taken up in the next six months and after that elections of Municipal Corporation are due and Code of Conduct will be imposed after August, 2011.

The Commissioner said that the estimates are prepared on DSR rates and market rates are obtained for non-scheduled items and DNIT is prepared. Tenders are invited on the basis of those rates. It is contractor to quote his rates on which he wishes to work and the contractors who quote the lowest

rate is allotted the work. There are too many projects to be handled and there is shortage of staff, particularly technical i.e. J.E. & S.D.Os, in comparison to the work. He requested the House to pass resolution formally for the safety of the officers, who are dealing with this issue that tender be evaluated on the current market price of the material, however, we cannot go beyond CVC guidelines. Secondly the time taken for the processing need to be cut down and thirdly advance planning is required, so that execution on the project could be commenced well in time. He assured that in the next 3-4 months a lot of work will be got done within the existing system.

Sh. Arshad Khan said that management, machinery, material and money are the four important tools of every project, which need to be set in place before planning any project. Every project should be managed with tools. There should be agreement with the contractor regarding non-disclosure, service level, non-competing and binding clauses are to be incorporated in the said agreement under which he will be bound to complete a project within a time frame. He desired that these agreements be brought in the House, so that the House could vet it. There is no proper monitoring and no system has been chalked out to execute the projects and there is no accountability. There is no management tool to monitor the project. Crore of rupees have been drained on over running of the cost of projects but management tools worth lacs of rupees have not been set in place.

The Mayor said that in the month of January a Special meeting will be convened to discuss the system management and to improve it. She requested all the members to come in House with their valuable suggestions.
