

MUNICIPAL CORPORATION, CHANDIGARH.

ORDER

WHEREAS being the highest bidder with bid amount of Rs.4,01,50,000/- for operation and management of Idle Truck Parking, Sector 26, Chandigarh Letter of Intent was issued in favour of M/s Nirba Associates, BMG house, Tehsil Compound, Rajgarh Road, Solan-173212, Himachal Pradesh vide Memo No. MCC/PPA/CK/2017/918, dated 31.08.2017.

AND WHEREAS, the said firm has failed to complete the formalities mentioned in Letter of Intent within stipulated time period.

Clause no. 1 of the terms and conditions reads as under:-

"The successful/highest bidder shall deposit advance license fee i.e. 25% of the accepted annual bid within seven days of issue of letter of intent. In case successful bidder fails to deposit the same, the earnest money of the successful bidder shall be forfeited and he/she/they shall not be allowed to participate in the E-Bidding/tendering/auction of Paid Parking Areas of Municipal Corporation, Chandigarh for next two years."

AND WHEREAS, Sh. Vijay Singh Thakur of M/s Nirba Associates, was given opportunity of personnel hearing on 20.09.2017. This office also intimated him telephonically to come present on 21.09.2017, but he also failed to come.

NOW, THEREFORE, I, Kriti Garg, IAS., Additional Commissioner, Municipal Corporation, Chandigarh, in view of above referred clause no. 1, hereby forfeit his EMD of Rs.5.00 lacs and debar M/s Nirba Associates, BMG house, Tehsil Compound, Rajgarh Road, Solan-173212, Himachal Pradesh to participate in the E-Bidding/tendering/auction of Paid Parking Areas of Municipal Corporation, Chandigarh for next two years i.e. from date of issuance of this order.
